11. Summary of the new findings of the thesis:

In addition to the list of references and appendices, the thesis is structured in three parts: Introduction, Main Contents and Conclusions. The thesis consists of four chapters: Chapter 1. Overview of the research problem; Chapter 2. Movement and development of Vietnamese prose from 1986 to present; Chapter 3. Author's ego and life picture in Vietnamese prose from 1986 to present; Chapter 4. Structure, language and tone of Vietnamese prose from 1986 to present.

The thesis has achieved the following results: 1) Covering relatively well the most typical authors and works of prose genre as well as quite fully covering relevant research documents; 2) Building a theoretical basis for the genre of prose writing enough to apply research to specific cases; 3) Analyze the historical, social, cultural and literary conditions for, the movement and development of prose genre after 1986 compared to the period before 1986 in Vietnamese literary life; 4) Pointed out and basically analyzed the specific features and meanings of the image system: the ego and the world of the post 1986 prose; 5) Identify and analyze the characteristics of prose from 1986 to present in terms of structure, language and tone.

In general, the thesis is a comprehensive and in-depth research on Vietnamese prose from 1986 to present. From the perspective of genre, the thesis has pointed out the characteristics of the movement, content, and expression of the prose, helping

readers visualize the appearance and contributions of the prose genre to common achievements of contemporary Vietnamese literature.

## 12. Practical applicability

With the achieved scientific results, the thesis is a necessary document for the study of students, trainees and PhD students in Literature major. On the other hand, we hope that the thesis will be a useful reference for the study of prose genre in particular and Vietnamese literature in general.

## 13. Further research directions

The thesis will continue to be supplemented, edited and published as a reference for Vietnamese literature. Accordingly, Vietnamese prose after 1986 can still continue to research and exploit in a number of directions such as: research on authorship, research on prose from the perspective of discourse, etc.
